# NO MASK MANDATE AFTER APRIL 9, 2021

### Youth Summer Camps

- Social Distancing
- Comply with previous order guidelines to refrain from:
  - High-fives
  - Handshakes
  - And other physical contact except to the extent necessary
  - o Only players, coached, and officials to participate directly in athletic activities
  - Wear facial coverings when within 6 feet of another except when directly engaged in sports activities
  - No sharing water bottles, cups or other drinking devices

#### Hospitals & Similar Institutions

- Beginning March 6, Hospitals and Long-term Care Facilities may
  - Allow up to 2 care-givers to accompany patients while receiving care
  - Allow up to to 2 visitors per patient/resident
    - Subject to:
      - Reasonable restrictions based upon the county positivity rates
      - Facilities COVID-19 status
      - Patient/Resident's COVID-19 Status
      - Caregiver/visitor's symptoms
      - Other COVID-19 restrictions set by federal regulations



#### Restaurants and similar establishments

- Employees must wear mask when serving patrons
- Buffets, salad bars, and self-serve drink stations may resume operation as long as they maintain 6 feet between patrons
- This change does impact K-I2 school cafeterias
